# Aboriginal Access Centre Grant Rules

- TSOs must seek to find funding from other sources such as JSAs prior to submitting a grant application.
- TSOs must have Page 3 signed and stamped by JSA if student is registered.
- The minimum grant application amount is \$250.  
(Aboriginal Access Centre will not fund under \$165 after the student commitment is deducted).
- Proof of Aboriginality with Common Seal must be provided.  
(Statutory Declarations will not be accepted)
- Students can only apply for one grant per Semester.
- AAC Grants will pay a percentage of student fees as per table below.

**Please note: grants for all certificate levels will be capped at \$1000.00 per semester**

Certificate Level	Semester 1	Semester 2
Cert II and III	1/2 of regulated fee – up to \$1000	1/2 of regulated fee– up to \$1000
Cert IV and above	2/3 of regulated fee – up to \$1000	2/3 of regulated fee– up to \$1000
